5. I accept the practice of Ju-Jitsu can be dangerous and holds the risk of serious injury. I also accept that it is my responsibility to maintain adequate insurance cover and to adhere to the instructor's commands at all times.

6. I agree that in the interests of safety, I will notify the instructor at the beginning of the class, of any illness or injury from which I may be suffering, and immediately, should an injury occur during the training session.

7. I accept that it is my responsibility to provide, that which is required in controlling any illness or condition from which I may suffer as this will not be available from the instructor.

8. I understand and accept that neither the association, or Gymnasium, nor any of their officials, will take responsibility for loss or damage to personal belongings or property.

9. I agree to attend training regularly and to come prepared with clean and tidy clothing suitable for practicing Ju-Jitsu.
